| Affiliates   | <ul> <li>Companies related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Credit Union Service Company of Virginia, LLC</li> </ul>   |
| Nonaffiliates  | <ul> <li>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Hampton Roads Educators' does not share with non-affiliates so they can market to you.</li> </ul>  |
| Joint marketing  | <ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Our joint marketing partners include insurance companies, financia services companies, and Enterprise Car Sales.</li> </ul>   |
